# MINUTES OF DISTRICT COORDINATION COMMITTEE MEETING CHINIOT HELD ON 16.09.2024 AT 11:00 AM UNDER THE CHAIRMANSHIP OF SYED ZULFIQAR ALI SHAH, MPA PP-96 IN THE COMMITTEE ROOM OF DEPUTY COMMISSIONER OFFICE, CHINIOT.

After recitation from the Holy Quran, the Convener of the District Coordination Committee, Chiniot, welcomed all the participants (list of participants is attached) and desired to proceed as per agenda.

The Secretary of the District Coordination Committee / Deputy Commissioner, Chiniot, presented the agenda of District Coordination Committee meeting, the respective department/executing agency gave presentation of their respective department as under:-

#### AGENDA ITEM NO. 1:-

#### REPORT ON THE 9TH CLASS RESULT IN THE DISTRICT CHINIOT

The Chief Executive Officer (District Education Authority) Chiniot, brief the house that result of 10<sup>th</sup> class in the District is 87%, HSSC is about 79% and 9<sup>th</sup> class result is about 50.76% while the overall BISE Faisalabad percentage is 48%. He further added that the results would be improved, if all the vacant posts of heads of educational institutes may be filled immediately by the government. He assured after filling up of these vacant posts, results would be improved significantly.

The chair expressed serious concerns over poor results of some schools i.e. 17.79% of G.T.I High School Chenab Nagar, 8.14% of GHS Al-Islah Chiniot and 17.17% of GHS Lalian and many others schools of District having such poor results. The chair asked the CEO (DEA) to exert efforts to improve the results in upcoming exams.

The Deputy Commissioner, Chiniot, directed CEO (DEA) to submit a detailed report regarding poor results of above-mentioned schools and dig out the reasons by serving show cause notices/ explanations to all heads/ teachers and concerned District Education Officer. The chair further directed that appreciation letters may be issued to heads/teachers having excellent results The Deputy Commissioner, Chiniot further directed the CEO (DEA) Chiniot to furnish detailed report of vacant posts of heads of educational institutions.

Mr. Taimoor Ali Lali, MPA PP-94, proposed that the parliamentarians may visit the schools of their respective constituency to check the attendance of teachers & students and others activities in the schools.

#### **AGENDA ITEM NO. 2:**

#### REPORT ON FLOOD AFTERMATH:

The District Emergency Officer, 1122, Chiniot, informed that 10 No. flood relief camps have been established in the District and no causality reported on account of flood, however some incidents related to monsoon were reported. He further informed that necessary action / response was taken in this regard as per policy.

The SDO Drainage, informed the participants that 01 No. stud at Mouza Sambhal hit by erosion and  $2^{nd}$  stud slightly got disturbed whereas condition of remaining studs are in stable condition.

The Deputy Commissioner, informed the chair that Government of Punjab, constituted a committee to recommend action in response to erosions so, in future, no direct funding desired without the recommendation of the committee.

The honorable MPA PP-94, Mr. Taimoor Ali Lali, desired XEN Drainage to visit Lalian to check erosion in Tehsil Lalian and present report for the same in the next meeting of District Coordination Committee.

#### AGENDA ITEM NO. 3:-

### PROGRESS ON TREE PLANTATION FOR THIS SEASON:-

Regional Forest Officer, Chiniot briefed that 65000 plants were planted in near past and survival rate of these plants is about 90%. The chair appreciated the progress of Regional Forest Officer, Chiniot.

#### AGENDA ITEM NO. 4:-

### REPORT ON BURNING OF PADDY CROP REMAINS:-

The Deputy Director (Agriculture) informed that notices were issued and awareness campaign for the formers / public was arranged. He further informed that on violation fine of Rs.15,000/- per acre will be imposed.

The honorable MPA PP-94, Mr. Taimoor Ali Lali, inquired about the progress on Kissan Card. The Deputy Director (Agriculture) informed that 48% registration has been done and remaining is under process. The Parliamentarian is

of the view that Kissan Card registration is not at par and directed DD agriculture department that campaign should be more intensive in coordination with concerned AC, Tehsildar and Patwari.

#### AGENDA ITEM NO. 5:-

### PROGRESS OF CHINIOT FAISALABAD ROAD:-

XEN Highways briefed that the project namely "Dualization of Faisalabad Chiniot Sargodha road from Kamalpur Interchange to Tehsil chowk Chiniot, District Faisalabad & Chiniot Length 24.00 Km" have been approved by PDWP and tenders will be opened on 21.09.2024. He further informed that section-6 of land acquisition has also been completed and acquisition of land is at final stage. He also informed that right of way on the main carriageway is clear, however pole shifting by FESCO and others utilities by SNGPL, PTCL and forest department are on service road area, so there is no issue in the execution / start of work on the main carriageway after completion of tendering process.

The honorable MPA PP-94, Mr. Taimoor Ali Lali, informed that summary regarding lane shifting of additional carriageway has been initiated and will be approved in the next meeting of Cabinet. He further informed that traffic count on the said road is about 16000, which is well above the required threshold of 10000 vehicles required for dualization, so rehabilitation is not feasible and Chiniot-Lalian road must be dualized. The District Coordination Committee (DCC) strongly recommended dualization of said portion on that is Chiniot to Lalian and desired XEN Highways to proceed accordingly for its dualization and communicate decision of District Coordination Committee (DCC) to higher ups. The District Coordination Committee (DCC) directed XEN Highways to halt the execution of approved rehabilitation.

#### AGENDA ITEM NO. 6:-

# PROGRESS ON SCHEMES UNDER CHIEF MINISTER DISTRICT SDGs PRORAM 2024-25:-

The Deputy Director (Dev.) Chiniot, informed that all 79 Nos. schemes identified under Chief Minister's District SDGs Program 2024-25 costing Rs.1480.000 (M) have been approved and summary for the approval of funds by worthy Chief Minister's Punjab was initiated by the Secretary LG & CD Department, Government of the Punjab. After approval by the Chief Minister's Punjab and approval of funds

from the Standing Committee of Cabinet on Finance and Development (SCCFD), the schemes will be included in ADP 2024-25 by P&D Board Punjab and funds will be released by Finance Department. The tendering process will be initiated after inclusion of schemes in ADP 2024-25.

The chair expressed satisfaction over the timely identification and approval of all the schemes under Chief Minister's District SDGs Program.

#### **AGENDA ITEM NO. 7:-**

## REPORT ON LAW AND ORDER AND TRAFFIC CONTROL IN CHINIOT:-

The District Police Officer, Chiniot, informed that there are some security threats about events of 12<sup>th</sup> Rabiul-Awal scheduled that is annual conference and processions of Majlis Ahrar-Ul-Islam from Kot Wasawa to Chenab Nagar Adda. He further informed that deployment plan for this event has been finalized. He further briefed the District Coordination Committee (DCC) that DICs meeting at district level were held on time to discuss and devise plan regarding law & order especially on the eve of 12<sup>th</sup> Rabiul-Awal that is arrangements of CCTV cameras and lighting on the routes of processions. The District Police Officer further informed that meeting with respect to this procession has also been conducted with Qadiani Jamat and all the arrangements to ensure law & orders have been completed.

#### AGENDA ITEM NO. 8:-

# DISTRICT SPORTS OFFICE TO REPORT ON SPORTS ACTIVITIES IN THE DISTRICT:-

The District Sport Officer, informed that Taicommando event has already been done and applications have been initiated for Khelta Punjab.

The Deputy Commissioner Chinito, directed DSO to prepare PC-I for construction of Tehsil Sports Complex Lalian including land acquisition cost. He further desired AC Lalian to provide land acquisition cost required for 32 Kanal in order to include cricket ground and volley ball area etc in the proposed project.

The honorable MPA PP-94, Mr. Talmoor Ali Lali, recommended that state land in the respective mouza jat may be declared as ground for sports activities like cricket and volley ball etc. The Deputy Commissioner, desired AC Lalian to identify such piece of state land other than the agriculture land to notify the same for sports activities that is cricket and volley ball.

The Chair desired DSO to plan for procurement of international standard volley ball along with nets and rules of the game to promote the said activity/game and exploring talent.

#### AGENDA ITEM NO. 9:-

# TRAFFIC ENTRANCE ISSUE OF RAILWAY CROSSING AT CHAK NO. 15/JB MONIANWALA (RAILWAY IN CHARGE CHINIOT TO DISCUSS AT PROBLEM):-

The District Officer Emergency (1122), informed that list of points where ambulances unable to cross railway phataks in District Chiniot have been prepared and communicated to Pakistan Railways for doing the needful. The Deputy Commissioner, Chiniot, desired DO (1122) to verify the list again and submit the same with recommendations that is, to what extent, the height of barriers at different railway phataks to be increased so that Ambulances may go through from existing barriers in the next District Coordination Committee (DCC).

#### AGENDA ITEM NO.10:-

## GENERAL DISCUSSIONS / DECISIONS:-

 The chair directed that XEN / SDO FESCO construction to be called in the next DCC meeting along with the progress of development projects as complaints regarding non completion of work against development projects / funds reported by public in many areas. In some areas poles are laying since long time which is a matter of concern.

 Electric connection, lights / poles at zero point Bhowana must be completed by XEN Highways at the earliest and restoration of plants to be done by the contractor in coordination with MC Bhowana.

 The DSP Traffic Police has recommended that MVE Chiniot to be posted permanently instead of additional charge.

4. The District Police Officer, Chiniot, desired that traffic signals to be installed on proposed 03 No. points as communicated earlier to CO MC Chiniot should be installed at the earliest.

The chair desired XEN Highways & CO Zila Council to start work on the berms
of roads damaged due to rain cuts especially on the sides of carpet roads.

6. The honorable MPA PP-94, Mr. Taimoor Ali Lali, recommended that dumpers to be avoided on carpet roads and barriers must be installed in such way so that the transportation of sugarcane may continue during the season then the barriers may block heavy traffic. He further recommended that patch work on Ahmad Nagar and others roads may be taken under sugar cess funds.

 The chair desired DSP Traffic Police to take necessary measures to avoid traffic problems / blockage on account of rickshaws etc at Rajoya Chowk.
